INVESTMENT

The Forever Fund remains in a strong financial position. With prudent financial practices, we can continue our vital support for the United Way's work across Central New Brunswick. Our portfolios with Fredericton Community Foundation (56%) and CIBC Wood Gundy (43%) and IG Wealth (1%) performed well, with returns that will support future contributions to the United Way. The Investment Committee continues to work diligently to ensure our funds are managed responsibly and act in accordance with the board-approved Investment Policy and Cash Management Policy.

The Forever Fund Endowment Fund ended the March 31, 2024 calendar year with a total investment portfolio balance of \$3.4 million, and returns of approximately 11%. In addition to the contributions of many long-term supporters, the Forever Fund received another substantial donation of just over \$100,000 in 2023-24. Our supporters ensure the Forever Fund will have a lifetime impact on both individuals, and the community as a whole.

The Investment Committee meets with the external managers throughout the year and would like to recognize our investors for the work they do behind the scenes to protect those investments so that the Forever Fund can continue to grow. Their care and commitment allow us, on behalf of our donors, to make sizable donations back to the United Way of Central NB and the community organizations it supports.

TREASURER

On behalf of all Forever Fund donors, the Forever Fund was proud to make our largest-ever donation to the United Way Central NB of \$136,500. This is \$38,000 more than the donation we made in 2023. This contribution has already enabled the United Way to support local initiatives addressing the needs within our area.

GOVERNANCE

One of the key achievements this year was our **Strategic Planning Session** in April 2024, led by **Karen Masry of Avise Consulting**. The session identified three strategic pillars: expanding our donor base, raising awareness of the Forever Fund, and supporting the board's work. These pillars will guide our efforts in the coming years.

Our Governance Committee made notable progress in updating our bylaws and policies. While the project has faced delays, we are actively collaborating with legal advisors to ensure completion by mid-2025. Additionally, with the support of our Endowment Officer, we are in the process of developing written policies, procedures, and detailed role descriptions to further strengthen our governance framework. In line with our efforts to modernize, we have also transitioned to saving and managing board documents online via SharePoint, with the goal of improving accessibility and document management for all board members.

- **Promotional video** since its screening during the Forever Fund's 25th Anniversary Celebration in 2023, the video can be found on the homepage of our website.






